From Metrolink or Amtrak at L.A. Union Station: By Car:

- SCAG is accessible by all Metrolink Service to Union Station.
- Transfer to the Metro Red Line or Purple Line (free transfer with Metrolink ticket) and get off at 7th St./Metro Center Station.

From Metro Red, Purple, Blue and Expo Lines:

- Exit train at 7th St./Metro Center Station. From 110 North/Harbor Freeway:
- Proceed up the escalators or stairs to street level and exit the Metro station.
- Walk north on West 7th St. towards Figueroa St.
- Cross north on Figueroa St. toward the Wilshire Grand Center and Intercontinental Hotel.
- Enter the office building at the right of the center's plaza through the double doors under the "Offices" sign.
- Proceed to the building security desk for sign-in.

By Bus:

- Merge onto James M. Wood Blvd.
- Take the 1st left onto S. Figueroa St.
- Turn left onto Wilshire Blvd.

INTRODUCTIONS

The Aviation Technical Advisory Committee (ATAC) Chair, Gary Gosliga, March Inland Airport, called the meeting to order at 10:06am. The meeting attendees introduced themselves.

OPENING REMARKS

Interim SCAG Executive Director, Darin Chidsey, introduced SCAG President, Hon. Alan Wapner. President Wapner introduced the ATAC as the technical working group that advises SCAG staff on regional aviation and airport ground access planning, including the quadrennial Regional Transportation Plan/Sustainable Communities Strategy (RTP/SCS). As part of his introduction, President Wapner described the history of aviation planning in the region. President Wapner noted how over the years the ATAC has picked up some of the regional aviation policy discourse functions of the now defunct Southern California Aviation Steering Committee by default. President Wapner emphasized that from here on out, the ATAC will not be involved in policy matters. Rather, aviation and airport ground access policy matters will now be addressed by the newly formed SCAG Aviation Task Force (ATF), which the ATAC will report to on a regular basis. The new ATF will also work with a newly created CEO Advisory Panel comprised of airport executive directors, directors, and presidents.

DISCUSSION ITEMS

1. SCAG's role as an MPO in Aviation and Ground Access Planning

Transportation Manager, Naresh Amatya, provided a brief introduction on SCAG's role in aviation and airport ground access planning. As the region's metropolitan planning organization, SCAG's focus is on surface transportation, including ground access to and from the region's airports. Due to the impact that traffic to and from the region's airport has on the surface transportation system, aviation is a critical element of the RTP/SCS and overall transportation planning for the region. However, SCAG does not have any authority over airport development and operations.

2. Overview of SCAG Aviation Element and its overall development process

(Note: the aviation element item was originally on the agenda after the next item, but Dr. Hiroshi Ishikawa decided to present the aviation program overview before the mission statement and ATAC membership item in order to provide context before discussing ATAC logistics.)

Associate Regional Planner, Dr. Ishikawa, presented an overview of SCAG's aviation element, including SCAG's role in aviation and airport ground access planning, the aviation element of SCAG's quadrennial RTP/SCS, the regional plan updating process, and the role that the ATAC will play in the upcoming RTP/SCS and SCAG's aviation planning in years to come.

3. ATAC mission statement, membership, and meeting format and frequency

Following the presentation on the SCAG aviation element, Dr. Ishikawa led a discussion on the newly revised SCAG mission statement. As part of the ongoing emphasis on ATAC's technical advisory role, SCAG staff have developed a new mission statement. After some feedback, it was decided that slight revisions would be made to the mission statement.

After discussing the mission statement, the meeting shifted focus to ATAC membership and meetings. Due to the de-emphasis on policy discussions in favor of technical information sharing, and the subsequent discontinuing of votes and positions on policy matters, the issue of ATAC membership is less relevant today than it has been in the past. Whereas in the past, only ATAC members were allowed to vote, ATAC meetings will no longer include votes on discussion items. Thus, the discussion of who are members, which have traditionally been planners from airports and transportation commissions/authorities, was resolved for the time being.

As for ATAC meetings, ATAC will continue to meet quarterly and on an as-needed basis. The next ATAC meeting is scheduled for December. Planning Director, Kome Ajise, recommended keeping the ATAC meetings on the second Tuesday of the month for the sake of consistency. Dr. Ishikawa stated that he will initiate a Doodle Poll to set the exact date of the next meeting.

4. ATAC Rolling Items/Information Sharing

Chair Gary Gosliga ended the meeting by discussing the ATAC Chair position and opening up the floor for comments. Although Chair Gosliga is open to continuing on as ATAC Chair, he welcomed volunteers for the Chair and Vice Chair positions. Despite opening up the ATAC Chair and Vice Chair positions for volunteers and nominations, no one expressed interest in either position during the meeting.

After the ATAC Chair discussion, the floor was opened up for general comment. Brendan Reed, Director of Planning and Environmental Affairs for the San Diego International Airport, offered to help coordinate regional planning efforts with the San Diego Association of Governments. Mr. Reed also offered to present on San Diego airport's ground access planning at a future ATAC meeting.

<u>ADJOURNMENT</u>

Chair Gary Gosliga, March Inland Airport, adjourned the meeting at 11:21am.
