Sustainable Communities Program (SCP)

- Technical assistance funding opportunity
- Fourth call for applications focuses on Civic Engagement, Equity, and Environmental Justice, funding land use and transportation projects
- Projects must be transformative and meet all funding objectives, by project category











Go Human Program Background

- SCAG launched its community engagement and traffic safety program, *Go Human*, in 2015 to reduce traffic collisions and encourage people to walk and bike more.
- The campaign supports a nexus between regional transportation goals & resources and neighborhood-level community solutions & strategies.







People who walk and bike are

3% daily trips

32% fatalities

PROGRAM PRACTICES

Coming to the table with resources!

- Begin with what you can offer
- People cannot engage when they don't have what they need; impacted communities cannot engage without resources.
- Through its community grants program, *Go Human* has distributed more than \$893,000 to 106 projects since 2018.

Go Human Community Hubs Grant Program

- Community grant program for community-based organizations, non-profits, and social enterprises. Awards up to \$40,000.
- A hub co-locates multiple resources to respond to community need, acknowledging that community members meet issues holistically and not through separate agencies or sources of support.
- Community Hubs leverages physical or digital community venues to increase access to *Go Human* traffic safety resources.

Who's Eligible?

- <u>PRIMARY APPLICANTS</u>: Cities and Counties; County Transportation Agencies; Transit Agencies; Tribal Entities; Natural Resources or Public Land Agencies; Public Academic Institutions; School Districts; Special Districts; Regional Housing Trust Funds; Housing Authorities
- <u>CO-APPLICANTS</u>: Community Based Organizations (CBOs); Non-Profits; All Primary Applicants are eligible as Co-Applicants
- Eligible as primary applicant for all funding





Project Categories



Housing & Land Use Strategies

Projects *must*:

- ✓ Be located in an infill area
- ✓ Accelerate infill housing production
- ✓ Reduce vehicle miles traveled
- ✓ Affirmatively further fair housing (AFFH)
- ✓ Implement Connect SoCal



Projects must:

- ✓ Reduce vehicle miles traveled
- ✓ Reduce greenhouse gas emissions
- ✓ Implement Connect SoCal

Example projects include:

- Affordable housing plans and ordinances
- Integrating infill housing into general plans

Example projects include:

- Vision Zero policy and programs
- Transportation safety plans
- Multimodal corridor plans
