ENERGY AND ENVIRONMENT COMMITTEE MINUTES OF THE MEETING THURSDAY, NOVEMBER 4, 2021

CALL TO ORDER AND PLEDGE OF ALLEGIANCE

Chair David Pollock called the meeting to order at 9:31 a.m. Staff confirmed a quorum was present. Policy Committee Member, Carmen Ramirez, Ventura County, led the Pledge of Allegiance.

PUBLIC COMMENT PERIOD

Chair Pollock opened the Public Comment Period and outlined instructions for public comments. He noted the total time period for all public comments related to items on the agenda and any other matter within the agency's subject matter jurisdiction was five minutes and the public comment period would be held open for at least five minutes to afford the public the ability to comment on all items on this agenda.

He reminded the public to submit comments via email to ePublicComment@scag.ca.gov. The Clerk acknowledged there were no written public comments received by email before or after the deadline. The Public Comment period was open for five minutes.

Seeing there were no public comment speakers, Chair Pollock closed the Public Comment Period.

1. Minutes of the Meeting - October 7, 2021

INFORMATION ITEMS

2. U.S. Green Business Council Los Angeles: Wildfire Defense Education and Tours

Ben Stapleton, Executive Director of U.S. Green Business Council's (USGBC) Los Angeles Chapter provided a brief overview of USGBC-LA's Wildfire Defense Education and Tours program which aims to bring together Southern California residents, the real estate industry, and the green building community together to take effective actions to save lives and property while mitigating fire risk. Furthermore, the program is designed to empower property owners, designers, and managers to proactively reduce wildfire hazards to minimize the loss of property and life, which helps to realize Connect SoCal's goal for the region to adapt to a changing climate.

Policy Committee Member Jonathan Ingram, Murrieta, asked if these services were available only in Los Angeles County and expressed concern over not having the infrastructure to help protect structures or the availability of grants. Mr. Stapleton acknowledged the question.

Policy Committee Member Daniel Brotman, Glendale, asked Mr. Stapleton if he could talk about what they were doing in building decarbonization. Mr. Stapleton stated they had been doing advocacy on the local level around decarbonization.

Second Vice President Carmen Ramirez, Ventura County, asked about information on insurance and discounts for people who engage in good practices. Mr. Stapleton indicated there were discounts available, but that several insurance carriers would not insure property unless they were forced to by the state.



Vice Chair Deborah Robertson, Rialto, asked what organizations they were working with in San Bernardino County and if they had interacted with the California Community College system to help get more people engaged with career opportunities. She indicated she would like to help them connect. Mr. Stapleton welcomed the introduction.

3. Orange County Equity Map and Social Progress Index

Katie Kalvoda, President and Board Chair at AdvanceOC provided a presentation on the Orange County Equity Map and Social Progress Index (SPI), which was developed through a public-private partnership between AdvanceOC, the County of Orange, and the Health Care Agency. SPI, used world-wide, was developed to enable users to identify root causes, understand social determinants, investigate disparities, and help create equity focused strategies and solutions. Using 50 indicators, SPI can measure, track, and map inequities with neighborhood precision.

Second Vice President Ramirez asked Ms. Kalvoda if she could comment on the living wage with respect to their calculations, specifically if they took into consideration the kind of income people have and what they spend on housing, health care and other things. Ms. Kalvoda addressed the question.

Vice Chair Robertson asked if they looked at other external reasons that were currently impacting communities that add to additional environmental and health factors. Ms. Kalvoda stated that when they started the SPI, they brought a variety of different stakeholders to ask them what data sets and information were valuable for the work they were doing.

Policy Committee Member Ingram expressed concern over the increase in homeless and asked how they could get resources and work together as communities to combine those resources, so that they could make an impact. Ms. Kalvoda stated she would welcome a conversation to see what they could do to help leverage this platform.

Policy Committee Member Margaret Clark, Rosemead, asked how they got the medical information without violating HIPAA regulations. Ms. Kalvoda indicated the data was provided by the Center for Disease Control and Prevention, where it's done in a non-identified way so that no one is identified.

Policy Committee Member Huff asked if the raw data had a breakdown of nationalities and languages. Ms. Kalvoda acknowledged the question.

Agenda Item 5 was taken before Agenda Item 4 to allow staff time to arrive to the meeting from another presentation. Agenda Items have been reorganized to reflect the order of presentations.

5. Water Supply and Drought Update



Danielle Dolan, Water Program Manager at the Local Government Commission (LGC), provided a presentation on the findings from LGC's statewide study on the Equitable Integration of Water and Land-Use, including how California's lack of watershed-wise planning has inhibited recovery from the COVID-19 pandemic and left cities unprepared for recent iterations of catastrophic fire and drought in California's natural climate cycle. Ms. Dolan also shared best practices and recommendations to ensure local communities and regions as a whole plan for these conditions and are better equipped to handle the climate impacts of drought, fire, and flood, even when compounded by economic instability and a public health crisis.

Vice Chair Robertson asked Ms. Dolan if she had provided this presentation or interfaced with the state legislative bodies or representatives. Ms. Dolan stated that they held a policy briefing for legislators and legislative staff when they first finished this report.

Second Vice President Ramirez requested more presentations at this Committee from the local water agencies as she felt the average water consumer did not understand or have knowledge where water comes from, what it takes to deliver, the cost, and what the looming drought meant for all of them.

Policy Committee Member Jesus Silva, Fullerton, expressed concern over the repeal of section 1412 of the Safe Drinking Water Act, current legislation regarding the Environmental Protection Agency bypassing the existing scientific process for determining the level of contaminants, and HR 2467 which puts the onus on water agencies to be liable for perfluorooctanesulphonate (PFOs) contamination.

4. Southern California Goods Movement Communities Freight Impact assessment

Alison Linder, Senior Regional Planner provided an overview of the Southern California Goods Movement Communities Freight Impact Assessment study which is expected to start November 2021. She reported this project, funded through a Caltrans Sustainable Transportation Planning Grant, would combine analysis and outreach to understand the positive and negative impacts of goods movement as well as the experience of these impacts on communities. This study would focus on public health, workforce development, and communications and outreach best practices. She further noted that key products included a toolkit for impacted communities with recommendations on goods movement impact mitigation and recommendations to connect communities to the economic opportunities of goods movement.

Vice Chair Robertson expressed concern over surrounding communities not having truck routes.
