3.0 INFORMATION ITEMS

3.1 Employer Travel Demand Management Data

This research analyzes survey data from 2004-2016 from SCAQMD's employer-based TDM program, known as Rule 2202, which allows employers to choose between implementing commute reduction strategies in order to meet performance standards or pay a fee-in-lieu based on their average vehicle ridership (AVR). After reporting descriptive program statistics, we conduct bivariate and regression analyses to determine which location characteristics, employer characteristics, and compliance strategies explain cross-sectional differences in AVR as well as AVR improvement in order to understand where future AVR increases might be realized.

3.2 California Freight Forecasting Model (CSFFM 3.0)

The California Statewide Freight Forecasting Model (CSFFM 3.0) is being developed to operate as a comprehensive statewide tool that identifies freight movements by truck, rail, and air. New data sources, such as statewide truck GPS data, micro establishment data, California Vehicle-in-Use (CA-VIUS) and Truck Monitoring System (TAMS), have been incorporated into the Model estimation process to improve accuracy and provide enough support to disaggregate the freight flows to 5,454 TAZs. The new non-freight truck module is also added to the model to enable a complete truck VMT analysis.

3.3 Towards Resilience Investigations with the SCAG RTDM

This presentation will talk about a novel model-based approach that couples an image-based structure-specific bridge modeling methodology with a metropolis-scale travel demand model (SCAG RTDM) to achieve a comprehensive and high-resolution resilience assessment. Due to its data-intensive nature, the proposed approach is capable of capturing and incorporating many details that are usually disregarded in traditional analyses, promising improved accuracy in estimating resilience and sustainability metrics of transportation networks.
