4.3 RTP Update

4.4 EPA updates

Wienke Tax, EPA Region 9, reported the following:

• EPA withdrew its previous approvals of South Coast VMT offset demonstrations for 1-hour and 1997 8-hour ozone standards, effective April 29, 2013. The EPA action triggered two sanction clocks in South Coast. If not resolved, stationary source sanctions would start in October 2014 and highway sanctions would start in April 2015. EPA is required to take action on updated

South Coast VMT offset demonstrations per a legal settlement agreement by August 2014.

4.5 ARB UPDATE

Cari Anderson, ARB, reported the following:

- Two updates were presented in the January ARB Board meeting and are available online:
 - 1) Air quality progress update in the South Coast region; and
 - 2) SB 375 implementation status update.
- Two presentations were given in the February ARB Board meeting:
 - 1) Presentation on latest science of ozone and PM2.5 atmospheric chemistry in South Coast; and
 - 2) Presentation on Proposed First Update to AB 32 Scoping Plan.
- The March ARB Board meeting has been canceled.
- ARB continues working on Imperial County SIP for 2006 PM2.5 standard which is scheduled to be presented to ARB Board in June 2014. Draft PM2.5 conformity budgets were expected to be completed this week.
- Minor updates to Western Mojave Desert and Coachella Valley 1997 8-hour ozone SIPs have been rescheduled for September 2014 ARB Board meeting.
- Next Statewide Conformity Working Group would be held on March 12, 2014. Meeting agenda and attachments were expected to be posted online next week.

Dan Garcia, SCAQMD, stated that SCAQMD had no new update.

5.0 INFORMATION SHARING
