4.3 FTIP Update

John Asuncion, SCAG, reported the following:

- 2013 FTIP Amendment #13-19 had received federal approval. •
- 2013 FTIP Administrative Modification #13-20 was anticipated to be approved • by early next week.

• Draft 2015 FTIP was under 30-day public review; first public hearing was held on July 10, and second public hearing would be held on July 24; 2015 FTIP is expected to be approved by SCAG's Regional Council in early September 2014 and by FHWA/FTA in mid-December 2014.

4.4 <u>RTP Update</u>

There was no new update.

Rongsheng Luo, SCAG, noted that Draft 2012-2035 RTP/SCS Amendment No. 2 was undergoing concurrent public review with 2015 FTIP including the two public hearings.

4.5 <u>EPA Update</u>

Wienke Tax, EPA Region 9, reported the following:

- EPA staff was in the process of responding to 1) six comments received regarding EPA's proposed approval of South Coast 1-hour ozone attainment demonstration and 2) one comment received regarding EPA's proposed approval of South Coast 1-hour and 1997 8-hour ozone VMT offset demonstrations.
- EPA would finalize these two approvals by settlement deadline of August 13, 2014.
- 4.6 <u>ARB Update</u> There was no new update.

4.7 <u>Air Districts Update</u>

Dan Garcia, SCAQMD, reported the following:

- Two elements of South Coast 2016 AQMP 2012 Baseline Emission Inventory and RACT Demonstration had been submitted by ARB to EPA.
- Seven of nine policy white paper working groups had met and discussed goals of their respective white papers; all meetings were open to public; and meeting dates and times are available on SCAQMD's website.
- 2016 AQMP Advisory Group intends to meet only periodically in 2014 but is anticipated to meet monthly in 2015 and 2016; and meeting information is provided on SCAQMD's website.

Ben Cacatian, VCAPCD, reported the following:

• VCAPCD had also submitted two elements of its AQMP - 2012 Baseline Emission Inventory and RACT Demonstration.
