The California Department of Transportation (Caltrans) has completed the review of the following amendment to the Southern California Association of Governments' (SCAG) 2018/19 – 2023/24 Federal Transportation Improvement Program (FTIP):

No. Description

13 **Local, State, and Transportation Systems**

- This amendment adds and modifies projects that include funding from the Highway Bridge Program, Congestion Mitigation and Air Quality Improvement Program, State Highway Operation and Protection Program, Highway Maintenance Program, Surface Transportation Program, Active Transportation Program, State Transportation Improvement Program, Federal Earmarks, and various Federal Transit Administration (FTA) programs.

SCAG has certified that the amendment is consistent with the Regional Transportation Plan, is financially constrained, is consistent with the regional emission analysis, does not affect timely implementation of the transportation control measures, and meets the requirements of public involvement procedures adopted by SCAG.


