#### **RECOMMENDED ACTION:**

#### **EXECUTIVE SUMMARY:**

Each year, the Nominating Committee meets to review and nominate the candidates for the SCAG officer positions for the upcoming year. On February 13, 2015, staff received applications from five (5) Regional Council members for the three SCAG Officer positions. The Nominating Committee is requested to consider the applicants and make one nomination each for the positions of President, First Vice-President and Second Vice-President.
