## 4.4 EPA Update

Karina O'Connor, EPA Region 9, reported that she had received facility availability information from Caltrans District 7 and SCAG and was waiting for response from EPA headquarters to schedule the training class on updated Quantitative PM Hot Spot Analysis Guidance in Southern California.

Wienke Tax, EPA Region 9, reported that Federal Register notice of EPA's final approval of Contingency Measures for South Coast 2007 PM2.5 SIP revision had not been published yet due to the partial Federal government shutdown. The EPA final approval will terminate the sanctions clocks and a federal implementation plan clock that were triggered by EPA's partial disapproval of a related SIP submission on November 5, 2011.

## 4.5 ARB Update

Jason Crow, ARB, reported the following:

- The Updates to Mobile Source Emissions Inventory Tools Workshop was held on Tuesday, October 8. The workshop materials had been posted on the ARB website at: http://www.arb.ca.gov/msei/workshop-meetings.htm.
- Anticipated EMFAC2013 development timelines: planning inventory in Winter 2013, a subsequent workshop in February 2014, beta release in Spring 2014, a final workshop in summer 2014, and release of final model in Fall 2014.
